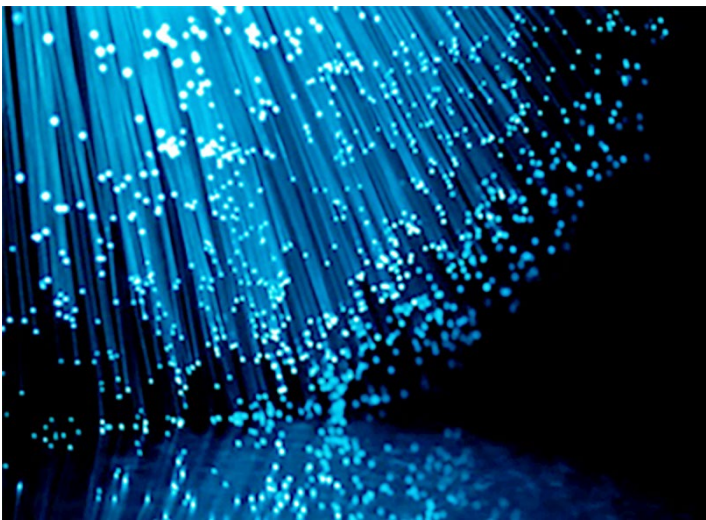

Purpose

This collection is in support the Momentum Approach to increase the number of students who complete gateway English and math courses during their first year of college.

The Academic Data Collection (ADC) collects institutional course enrollment and grade data for these Mathematics and Writing courses, but it does not collect all necessary data to evaluate credit from the following sources:

- Transfer credit from an external institution
- Testing (AP, CLEP, etc.)
- Other Advanced Standing Sources

Overview

The Transfer Course Collection includes additional data for students who:

- Have a Student Level code of less than 60
- Matriculated during the past academic year
- Have transfer credit in level 1000-2999 English (ENGL), math (MATH) or/and statistics (STAT)

ITS will extract transfer course enrollment and grade data over existing database links.

The following data fields will be included in the collection.

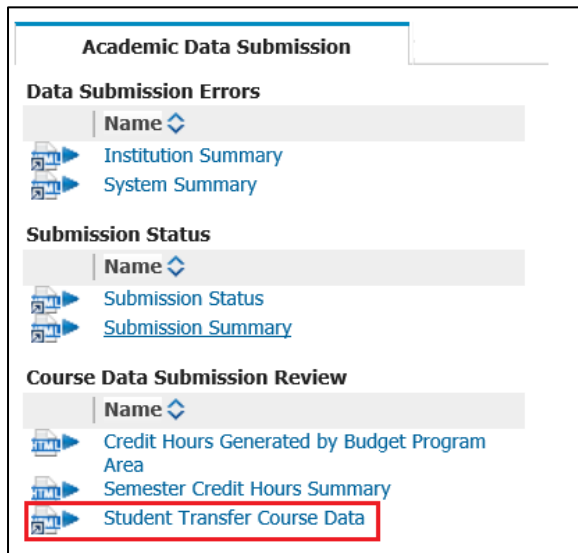
