- **Cycle:** Bi-Weekly until June 6, 2026, then weekly
- **Data Snapshot:** Saturday
- **Submission Form Open:** Sunday
- **Submission Deadline:** Tuesday by 5:00 PM
- **Data Lock (no edits):** Wednesday at Noon
- **USO Review:** Wednesday
- **Rejected Data Re-Submission Deadline:** As soon as possible, but no later than Friday at Noon
- **Net Analysis Available:** Friday or following Monday

- Enrolled should be \leq students accepted

- Paid in full should be \leq students enrolled

The **Enrollment Monitoring Report Dashboard** visualizes weekly enrollment monitoring data for **undergraduate students** in an interactive way with several pages for analysis. The weekly enrollment monitoring report captures critical admissions and recruitment information, in addition to dual enrollment, continuing student enrollment, and housing metrics at the undergraduate level. The reported data compares the upcoming fall term to the previous, analogous fall term for that particular collection date.

Participating institutions: All institutions as of 2024. Georgia State University submits separate reports for the downtown campus and Perimeter College.

High-level summary of all elements for Fall 2023 and Fall 2024.

Weekly Analysis

Analysis of weekly change for various elements. Tables, bar charts, and line charts used to emphasize change.

Annual Analysis

Analysis of year over year change for various elements, with "classic" and "detailed" views.

Annual Analysis of enrollment pipeline elements with student type filters.

Sector Net Analysis

Changes in enrollment year-over-year for each collection cycle. Data is presented in a table.
